



2025-2025 Membership Plan Rec Academy Soccer Program

MEMBERSHIP

1. Definitions
 - a. The “soccer year” is the period between 8/1 to 7/31 of the following year.
 - b. The 2024-2025 “soccer year” is the period between 8/1/2024 and 7/31/2025.
 - c. There are three seasons within the “soccer year” named Fall, Winter, and Spring.
 - d. A child can participate in any of the individual seasons contingent upon payment.
2. The membership term is defined as follows.
 - a. The membership term begins with the event that occurs last; the first payment for an individual season or the first event of an individual season.
 - b. The membership term ends with the last event of an individual paid season.
3. Membership is granted strictly to the participating child, also known as the “player”.
4. Membership is not transferable to another child or an adult.
5. Membership is terminated upon a child leaving the program.
6. FSCI can terminate membership if a player or parent violates the Code of Conduct.
7. The child is a member of FSCI and not of a specific team.
8. Participation eligibility is contingent upon being current on payment, agreeing to the terms of membership, and compliance with the following documents.
 - a. Rec Academy Program Rules
 - b. Code of Conduct
9. Membership is contingent upon electronically signing these documents.
 - a. Membership Agreement
 - b. Membership Plan

BENEFITS – TRAINING & GAMES

1. Membership dues cover the cost of coaches, fields, equipment, insurance, practices, games, and administrative support.
2. The table below outlines the specific number of training sessions per season for a given membership level.
3. A membership level may not be available if enrollment is full or not offered.
4. FSCI reserves the right to vary the number of scheduled training sessions per week provided that the total number of scheduled training sessions per season is met.
5. Training sessions are either 45 minutes or 60 minutes long.

3. FSCI reserves the right to adjust the start date and end date of each season provided that these dates fit within the “soccer year”.

MEMBERSHIP DUES

1. The membership dues for each individual season are outlined below.
2. FSCI reserves the right to offer early bird discounts on the membership dues prior to the first event of the season.
3. Membership dues are not prorated if a player joins the season late.

POLICIES

1. If there is a cancellation or a same-day schedule modification, FSCI will notify everyone via our social media pages. It is the responsibility of the parent and player to check our social media pages prior to the event.
2. If there is a full or partial cancellation of an event, we will attempt to make up the missed time. Makeup events can occur at any time or any day. We will make up the missed time by either adding makeup days, extending the time of existing days, or holding 2 sessions on 1 day.
3. Parents need to monitor the weather forecast and arrange to have their child picked up if inclement weather causes issues during an outdoor or indoor event. Some outdoor locations do not have an available shelter. Therefore, it is important that rides are present in the event of inclement weather.
4. Children can request to play on the same team with another child provided that both children are in the same birth year or in adjacent birth years.

ELIGIBILITY

The table below lists the birth years that are eligible to participate for a certain membership level.

DISCLAIMERS

1. There are no refunds regardless of reason or circumstance.
2. If a card payment is declined, there is a \$20 reinstatement fee.
3. If a card chargeback occurs, there is a \$50 reinstatement fee.
4. If a payment is declined or a chargeback occurs, a player ceases participation until payment is made. This applies regardless of previous payments.
5. Schedule is subject to change due to weather or unforeseen circumstances.
6. FSCI reserves the right to combine age groups at any point during the membership term.
7. FSCI reserves the right to provide a substitute game, league, or tournament.
8. If a player misses an event, FSCI will not provide another event.
9. There exists a scenario where a child can be a member and not participate. It is the responsibility of the parent, legal guardian, and child to ensure compliance with all participation eligibility requirements to avoid this scenario.
10. The parent consents to receiving communication from FSCI via email, text message, and phone.
